As of 1 July 2023 Card holders and applicants must notify the WWC Screening Unit if they have a change to their name, residential address, contact details or child-related work status.

As a church community, we can continue to improve inclusivity, by embedding the National Catholic Safeguarding Standard

- ⇒ Standard 2 Children and adults are safe, informed and participate ~ **enabling children with** disabilities to participate in decisions affecting them.
- ⇒ Standard 3 Partnering with families, carers, and communities ~ providing accessible ways for children with disabilities to provide feedback and input into child-safe practices.
- ⇒ Standard 4 Equity is promoted, and diversity is respected ~ *proactively anticipating children's diverse circumstances and providing support and responding to those who are vulnerable*.
- ⇒ Standard 8 Safe physical and online environments ~ creating physical and online environments that are safe and accessible for people with disabilities and promote safety and wellbeing.


16 DAYS OF ACTIVISM AGAINST GENDER-BASED VIOLENCE



Andrea Musulin was instrumental in developing the Safeguarding Program within the Archdiocese of Perth in 2015. Starting as a pilot project, the Safeguarding Program is now well established in the 209 Parishes and numerous Agencies of the Archdiocese of Perth.

The program has also been adopted by the Province of Western Australia with safeguarding represented in all Diocese's of Western Australia.

Andrea's wealth of experience spanning over 30 years in child protection and family and domestic violence support placed the Archdiocese as a leader in child protection post the Royal Commission into Institutional Responses to Child Sexual Abuse.

After a well rested period of two years leave, Andrea has made the decision to resign as the Director of the Safeguarding Program. The Archdiocese has been extremely fortunate to have had Andrea's guidance and passion over the past 8 years.
